#### THE CORE AREAS OF COOPRATION /Scope:

- a) Both the institutions shall evolve a mutually acceptable schedule to develop programs, hold seminars and exchange visits.
- b) The said academic interaction and intellectual assimilation may include
  - i. Faculty/staff development and exchange
  - ii. Exchange of students
  - iii. Conduct jointly Seminars, research, conferences and workshops
  - iv. Collaborations in the sharing of academic data
  - v. Placements and training programs for students
  - vi. Inter-Collegiate Student Research Journal
  - vii. Inter-library loan and use of e-library
  - viii. Sports and Yoga and Certificate Courses
  - ix. NSS Activities Organising Special Camps
  - x. Training Workshop for Non-Teaching Staff
  - xi. Inter-Collegiate collaboration for Cultural activities

#### MISCELLLANEOUS:

- a. The details for the efficacious implementation of this Memorandum of Understanding shall be jointly worked out on mutually acceptable terms within the parameters of the policies, rules and regulations of both the institutions.
- b. The parties to this memorandum may, by mutual consent, add modify, amend, delete, review or revise any tem(s) and condition(s) of this agreement.
- c. The intent and implementation of this memorandum is SUBJECT to the policies of the respective Institutions and the laws of the land.
- d. The MOU shall remain in force for a period of 5 years from the date of its signature and seal, and may be terminated by either side by giving a six months' notice to that effect in writing. However, notwithstanding the notice of the intent to terminate the memorandum, all rights, obligations and corresponding duties and subsisting therein shall be respected and mandated till the finalization and accomplishment thereof.
- e. The parties to this MOU undertake to treat as CONFIDENTIAL AND PRIVILEGED information of the other institution, which is so classified in advance. The terms of confidentiality and mode of disclosure shall be as per mutually acceptable terms.
- f. For the organization of the programmes, the organizing institution / college will incure the expenditure. And for joint venture, the expenditure incurred will be equally shared by both the institutions. For students and teacher exchange, event and research activities, the commutation expenditure will be borne by the institution that visits the other institution / college.
- g. The institutions in the memorandum of understanding shall be free to add other Institutions in their Collaborative Ventures(s).

- h. In case of any dispute arising in any aspect of the academic co-operation, Principal of the Institutions shall jointly resolve the dispute(s) in the spirit of mutual respect and shared responsibility.




